If not, Performer is responsible for supplying the stage for his/her/their performance, if one is necessary for the effective delivery of the performance.

Contractor shall make every effort to prevent any recording or transmission of the Performance without the written permission of Performer or Manager.

Contractor and Performer shall be excused from their obligations hereunder in the event of proven sickness, accident, riot, strike, epidemic, act of God or any other legitimate condition or occurrence beyond their respective control. Under any of these conditions, the deposit tendered to Performer or Manager shall be returned to Contractor.

Contractor shall be entitled to use the names, likenesses, and other promotional materials provided by Performer or Manager for the purpose of promoting the Performance and attracting attendees.

Contractor shall provide adequate parking space within _____ feet nearest the stage entrance and shall reserve such parking space for Performer's exclusive use from four hours before the starting time of the Performance until three hours after the Performance's ending time.

Setting up instruments and organizing music will be the responsibility of **Musician**, but no other part in setting up the event will be expected of **Musician**.

It is understood that special circumstances may arise in which this agreement may be altered. In cases of a venue change, extended duration, and/or other difficulties, parties may meet to discuss alterations, which must be amenable to both.

If the event is cancelled for any reason or the musician is not needed, the deposit will be forfeited. If **Musician** must pull out of the event for reasons of illness or other interferences beyond the **Contractor's** control, the deposit will be returned to **Contractor** and a list of suitable replacements will be provided.
