What information do we collect?

What do we use your information for?

The information we collect from you may be used in any of the following ways:

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your account. In addition, we offer the use of a secure server.

All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our payment gateway provider's database only to be accessible to those authorized with special access rights to such systems. These individuals are required to keep all information confidential.

After a transaction, your private information (i.e. credit cards, social security numbers, financials, etc.) will not be stored on our servers.

Do we use cookies?

Yes.

Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) which enables the site or service provider's systems to recognize your browser to capture and remember certain information. In addition, we use cookies to help us remember and process the items in your shopping cart, understand and save your preferences for future visits, keep track of advertisements, and compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.
